#### Referencing

All texts referred to in the paper must be appropriately referenced in a list of "References" at the end of the text. Further, all notes are to be included as endnotes ("Notes"). A bibliography is not to be included.

The author is responsible for the accuracy of references and quotations. We expect the author to check them thoroughly before submission.

#### **Figures, Charts, and Tables**

Illustrations and charts must be referred to by figure number and source. Tables must be referred to by table number and source.

#### Length of Contribution

Papers should be approximately 1,200 to 3,000 words, with supporting graphs and charts.

#### Format

We ask for submissions in MS Word or other text format, as well as a PDF. Charts and graphs may be in .GIF or .JPG, but we ask that authors also keep a .TIF format in case it is required for printing purposes. An Excel spreadsheet supporting your submission may also be included.

#### **Licenses and Copyright**

We require all submissions to include the author's signature on the Publication Agreement at the end of this document.

We may publish online. We require that you place your submission under the Creative Commons AttributionNonCommercial 3.0.

Unless another license is noted, we will assume that your contribution is under this license.

### **Member News**

#### **Canadian Association for Technical Analysis (CATA)**

I reported to IFTA readers one year ago that "there is a new kid on the block."

The Canadian Association for Technical Analysis—CATA—was formed one-and-a-half years ago. This is a result of former IFTA member Canadian Society of Technical Analysts (CSTA) spinning off the non-professional members.

At year end in 2022, the "new kid" had 60 paid and five honorary members. CATA holds two monthly meetings via Zoom and held an in-person national conference 15 October 2022 in Calgary. Members were represented at the conference from across six different Canadian time zones.

Our twice-monthly meetings start at 8:00 PM ET, with the structure of a presentation by a speaker that leads to Q&A. The speaker and Q&A generally take two-thirds of the two-hour meeting. The president presents a few minutes of greetings and administration at that rough mid-point. That last half of the meeting is available for the attending members to open their mic and enter into a live Q&A conversation with our renowned speakers. In many meetings, the guest speakers continue with chart questions/comments posed by the individual members. In this second half of the meeting, two of our directors call up the charts, mark the charts, and host the discussion on what is happening. The meeting will wrap up at the two-hour mark. By then, it's pretty late throughout the country.

To repeat what I said before and to add, I am so pleased that a group of us were able to enact a plan for the non-professional chartists in Canada, and that we have a viable structure going forward. In 20 months of hard work, we have a name, a logo, a website, a membership base, renewing members, positive finances and 17 months of two meetings per month.
