





Memoriam

Gregory Allen Schnell

1961 (Estevan, Saskatchewan)-2024 (Calgary, Alberta)

Greg Schnell of Calgary passed away from glioblastoma on June 6, 2024, at the age of 62. Greg's illness progressed rapidly. On July 28, 2023, while preparing to tee off on the third hole, he suffered a seizure that revealed a hidden brain tumor. Despite receiving excellent diagnostic care, there is no cure for this type of brain cancer.

Greg was renowned worldwide in the technical analysis community and was a prominent figure in Canada. He led the Calgary Chapter of the Canadian Society of Technical Analysts (CSTA) for a decade.

He was a speaker at the International Federation of Technical Analysts (IFTA), attended global conferences, presented his work on Stockcharts for ten years, and co-authored Stock Charts for Dummies. In 2020, he began presenting his subscription work at Osprey Market Strategies.

Over 150 people attended his memorial service, which was also broadcast live on the internet.

Greg was a wonderful man, a neighbor, friend, and colleague. He is deeply missed.

IFTA Board of Directors Nomination Form
